The Impound Authorization Contract will serve as "authorization" for STATEWIDE WRECKER SERVICE to tow illegally and/or remove improperly parked vehicles from the stated private property. An Impound Authorization Contract must be completed for EACH property that you are requesting services for.

IN ACCORDANCE WITH DMVS REGULATIONS PRIVATE PARKING SIGNS MUST BE POSTED FOR AT LEAST TWENTY FOUR (24) HOURS BEFORE ANY VEHICLE CAN BE TOWED. GEORGIA CODE 44-1-13 WILL BE FOLLOWED. STATEWIDE WRECKER SERVICE WILL PROVIDE SIGNS AT A COST OF \$30.00 PER SIGN.

THIS AGREEMENT DOES NOT INCLUDE THE REMOVAL OF JUNK VEHICLES, LOOSE DEBRIS, TRASH, OR ANY NON-OPERATIONAL ITEMS NOT CLASSIFIED AS LEGALLY IMPOUNDABLE MOTOR VEHICLES. PLEASE NOTE THAT ANY PROPERTY REQUESTING JUNK REMOVAL SERVICES WILL BE CHARGED A MINIMUM FEE OF \$228.00 PER PICK UP.
